#### A Message from Our Board

On September 28, 2022, Hurricane Ian made landfall in Coya Costa as a Category 4 Hurricane. With maximum sustained winds of 155 mph, Hurricane Ian is tied for the 5<sup>th</sup> largest storm on record.

The days prior to landfall, it appeared as the Tampa Bay area was in the path for a direct hit. While the Suncoast chapter areas had evacuations mandated, shelters opened and our residents preparing, our building departments were planning for what would also be required once the storm passed.

While the Suncoast areas were mainly spared from the impact of Hurricane Ian, we know that we can be in the "cone of uncertainty" at any point during Hurricane Season. The adoption of modern building codes, and the work that we complete daily to enforce these codes, protect buildings and people from these hazards.
